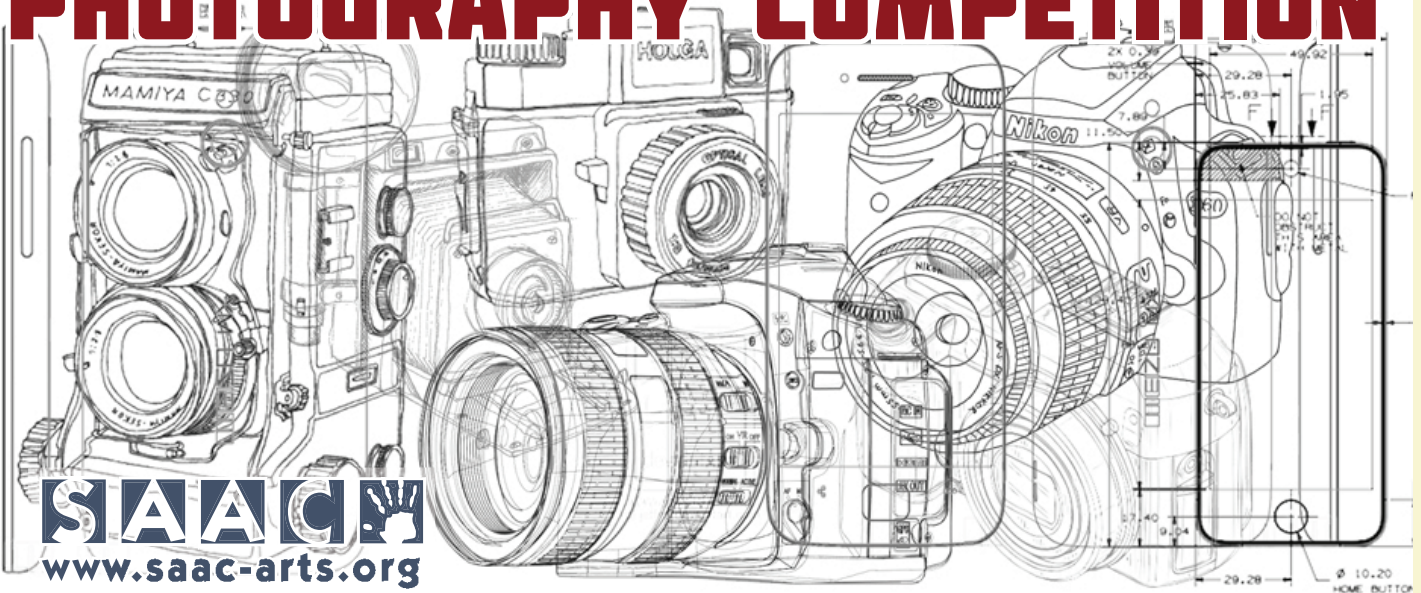

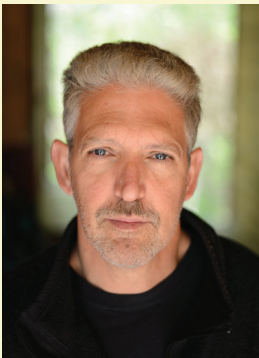

JUDGE: STEVEN E. OCHS



Steven Ochs is a Professor of Art at Southern Arkansas University with 37 years of experience in education. He has been serving as the Chair of the Department of Art and Design and is the owner of Public Art Walks, which specialize in public art projects utilizing decorative concrete.

Steven mainly teaches basic and advance photography, ceramics, sculpture, 3D design and is currently serving on the Magnolia Arts Council. He has received awards in both teaching and research. In 2013, Steven was awarded SAU's Honor Professor of the year. He has published numerous articles about creating and marketing decorative concrete,

photo-documentation, and has been a presenter and artist at the World of Concrete, Concrete Décor Show and Bosch Tool events.

In November of 2016, He collaborated with the Art Professors of Artemisa Cuba to create a large mural on their campus and co-presented this project at the Universidad 2018 in Havana.

Steven holds degrees from the following: B.A. from Eastern Illinois University, Charleston; M.A. from the University of Illinois, Champaign-Urbana; M.F.A. from Ohio University – Athens.

JUDGE: Steven Ochs, Professor of Art and Chair of the Department of Art and Design at Southern Arkansas University

DEADLINE: Entries must be received in the SAAC Office by February 3, 2020.

ENTRY/FEE: Limit 2 pieces per person with an entry fee of \$10 each for SAAC Members and \$15 each for General Public (Entry fee is non-refundable.) Make checks payable to SAAC.

AWARDS: Cash prizes will be awarded to the Best of Show (\$300), First Place (\$150), Second Place (\$75), Third Place (\$50), and Honorable Mention (\$20).

ELIGIBILITY: Photographs can be take with any type of camera and printed on any medium. Basic corrective editing in the dark room or digitally on the computer is allowed but no graphic manipulations. Photographs must have been taken in the last five years and not previously shown at SAAC. Each piece must be ready for display in the gallery with a sufficient hanging method. No work done under supervision or in a classroom environment will be accepted. The judge and show chairperson have final authority to define what constitutes an acceptable entry.

DELIVERY/PICK-UP: Works must be delivered to SAAC by February 3 and picked up on February 27. Artists are responsible for the delivery and pickup of all works. Shipped pieces must include a return shipping label or instructions when received. Work not picked up after 30 days will become the property of SAAC.

EXHIBITION: All works will be on exhibit in SAAC's Galleries February 5-27, 2020. An Artist Reception will be held February 21, 5:00-6:30pm with an awards presentation at 6:00pm. All work must remain for the duration of the exhibit.

SALES: Sales are encouraged. A 35% commission will be charged on all sales resulting from the exhibition. Works NOT FOR SALE must be marked NFS.

WAIVER: Any work submitted to SAAC for exhibition may be reproduced for promotional purposes. The receipt of an entry in the competition will constitute agreement by the artist with all conditions set forth in the prospectus.
